ENSURE OPTIMAL FIT

When you feel the installed eartip is too small or too large, replace it be a bigger or smaller size as shown.

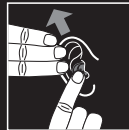

HOW TO WEAR YOUR PEARLS



Hold the Pearls between your fingers with the eartip pointing towards the ear canal.



Pull up your ear and insert the Pearls.



Ensure the position feels comfortable. Hold the Pearls for about 5 seconds to be sure of a good sealing effect.



Done! Now you can enjoy music responsibly.

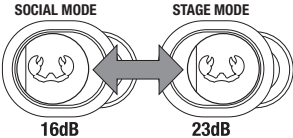
